Proposal: It is proposed to install coastal revetment structures along three (3) sections of the foredune on the Hartenbos beachfront. These sections are currently stabilised with historic gabion structures, which have deteriorated over time and are no longer regarded as safe or effective under dynamic coastal conditions and ongoing erosion. The proposed interventions are intended to stabilise the foredune, safeguard municipal and ATKV infrastructure, and mitigate long-term erosion risks. The preferred revetment option is the installation of sand-filled geotextile containers (sandbags), with rock-filled wire baskets (gabions) also considered as an alternative.
