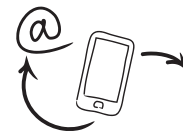

Detailed description of proposal:

- Application in terms of Section 15(2)(a) of the Oudtshoorn Municipality: By-Law on Municipal Land Use Planning (2016)(as amended), for the rezoning of the Remainder of Erf 6444 Oudtshoorn from Agricultural Zone II to General Residential Zone IV to allow for the conversion of the existing dwelling house to a guest lodge.
- Application in terms Section 15(2)(b) of the Oudtshoorn Municipality: By-Law on Municipal Land Use Planning (2016)(as amended), for a permanent departure for the relaxation of the following building lines on the Remainder of Erf 6444 Oudtshoorn:
 - The rear boundary building line from 4.5 metres to 0.246 metres to accommodate the existing store, proposed toilet, kitchen and braai chimney which form part of the existing pool-entertainment area.
 - The western side boundary building line from 4.5 metres to 4.171 metres to accommodate the existing covered patio on the north-western side of the main building

Notice is hereby given in terms of Section 45 of the Oudtshoorn Municipality: By-law on Municipal Land Use Planning (2016)(as amended), that the abovementioned application has been received and is available for inspection during weekdays - **only by appointment** at the Town Planning Department at 92 St John Street.
